ASSIGNING UPDATE – GYMJAS Ames

Ames shared screen with number of judging assignments for 2020-21 & 2021-22 Assigning in gymjas was discussed.

2. FINANCIAL REPORT Ames / Buell

Balance in account is 43,750.00

\$6000 earned at both fundraisers (Candy Corn & Reindeer Games)

\$2640 spent on dues. \$7431.44 testing costs. Total – 10,071.44 for education/dues

3. STATE CLINIC Ames

Nicole Elves (USAGWA education rep) is working with NAWGJ to finalize topics for State Clinic.

Dates for clinic are June 24 – 26th, 2022.

Question – (Riley) Will there be any other educational opportunities in the spring. Green – Yes. (more about that later in meeting)

MENTORING COMMITTEE REPORT Hickey

6. 2022 TESTING INFORMATION Hickey

A new part is the Personal Improvement Plan (PIP). You can put together a specific plan for Improvement when you don't achieve the required score on an event. Dates will be available after August for activities to count toward PIP and must be completed by 12/31/2022.

Practical verification will be hosted at each regional Congress with a mock exam on Saturday night.
